FAST CAT

Fast CAT is open to all dogs 12 months of age or older that are individually registered/listed with the AKC registration as purebreds, Foundation Stock Service (FSS) dogs, Purebred Alternative Listing (PAL) dogs and AKC Canine. Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.

The FAST CAT is a timed straight race of 100 yards where a dog chases a lure. Dogs are run singularly and earn points based on their handicapped speed. There are no placements. Titles are issued at designated benchmarks. The dog's time to complete the 100 yard dash is converted into MPH. Dogs earn points based on their handicapped speed. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- 18" or greater = handicap is 1.0
- 12" up to less than 18" = handicap is 1.5
- Below 12" = handicap is 2.0

Points = MPH multiplied by the dog's handicap

Titles are earned by accumulating points. The following titles will be awarded:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = every addl. 500 pts.

Top 20 by Breed by Year: The AKC Fast CAT website will feature the Top 20 Fastest Dogs by Breed by Year national standings. The standings will be updated as event results are processed.

ALL DOGS RUN AT OWNERS SOLE RISK

IMPORTANT GENERAL INFORMATION

- All entries must be 12 months of age or older on the day of the test.
- Each dog requires an individual entry form for each event in which it is entered.
- Entries will not be accepted without fees, signatures, or the "Agreement" found on the Official AKC Entry Form.
- Bitches in season and lame dogs will be excused. Entries will be refunded.
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- Coursing is an athletic activity that can tax a dog's physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion.
- The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.
- *A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress, or course delays.*
- Battery-powered continuous loop equipment will be used. Lures consists of a white plastic bag.
- FAST CAT course will be fenced with 36" farm fencing.
- FAST CAT start will be clearly marked with a 10-foot start box where the dog's front feet *MUST* be inside the start box.
- FAST CAT and CAT courses will be on a natural grassy field.
- CAT field will have natural water boundaries on three sides and fencing on the fourth side.
- There will be **NO HOT STARTS** (where the dog is released as the lure passes the dog).
- Handlers will NOT release their dog before the "T" in "Tally Ho" or prior to the lure moving down the course (dogs *MUST* be chasing a moving lure for the run to qualify).
- FAST CAT course run-out will be at least 35 yards.
- The lure will NOT be used to recall dogs. As soon as the dog completes the run, the catcher needs to remove the dog from the FAST CAT course so there are *NO COURSE DELAYS*.
- FAST CAT runs will be timed with timing equipment where scores are recorded to the nearest 1/100th of a second). In the event of equipment failure, runs will be hand timed.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- The field committee reserves the right to bar known aggressive dogs from the trial site.
- Persons exhibiting conduct detrimental to the AKC/WVBC/any dog(s)/other person(s) will be asked to leave the trial site.
- Bring your own shade and water.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.
- The event-hosting club, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

COVID-19 (CORONAVIRUS) SOCIAL DISTANCING PLAN

The following plan is designated at this time for the Willamette Valley Basenji Club Inc. All Breed Dog Show, Participating Breed and Group Club Specialty Shows, Agility, Obedience, Rally, Barn Hunt, Lure Coursing, and Dock Diving. (This plan is subject to change as the details outlined above change.)

DUE TO COVID-19 GUIDELINES, THE PUBLIC IS NOT INVITED TO ATTEND THESE EVENTS.

1. IF YOU ARE ILL, FEEL UNWELL, COUGHING, SNEEZING OR RUNNING A TEMPERATURE:

Please stay home.

2. EXPOSURE TO COVID-19: If you have recently been in the presence of a person who has either tested positive for Covid-19 or has the symptoms (coughing/sneezing/temperature) please stay home.

3. INSPECTION/ROLL CALL: A designated staging area will be provided for FAST CAT and CAT inspections. There is no designated order for inspection. Please maintain social distancing until it is your turn.

4. INDEX CARDS: At the present time the plan is to issue index cards at inspection. Please make sure your catcher has your card when it is your dog's turn to run. If the catcher does not have your card when your dog comes to the line, the party releasing the dog will be asked to take the dog and come back to run when the catcher has the index card. Maintain social distancing while waiting for your turn to run your dog.

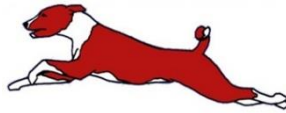
5. STAGING AREA: A designated staging area will be provided for FAST CATs at the START and FINISH lines. Please remain in this area and maintain social distancing until it is your turn.

6. CLUB TENTS: The club tents at ringside are meant for the use of exhibitors and club members only. Please do NOT bring your dog under the club tents (only at the tents while you are in line to run your dog).

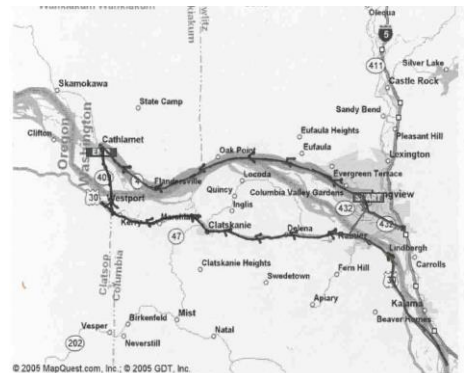
DIRECTIONS TO MISTY RIVERS PLANTATION

By Way of I-5 North and South

- Off of I-5 take Exit 39 West toward Kelso/Longview 0.2 miles.
- Turn LEFT onto Allen St/WA-4. Continue on Allen St 0.9 miles. Allen St. becomes W Main St. 0.2 miles.
- Turn Left onto W. Cowlitz Way / Wa 4 less than 0.1 mile. Turn Slightly Right onto Ocean Beach Hwy / Wa 4 go .25.2 miles.
- Turn Left onto Main St / WA 409. Continue to follow WA 409 for 2.0 miles.
- Turn Right onto W. BERNIE SLOUGH RD 0.8 miles.
- Turn Left onto Cross Dike Rd after 0.7 miles. End at 117 Cross Dike Rd.

Off of Highway 30 West from Portland Wahkiakum Ferry

- In Westport Turn SLIGHT RIGHT onto WESTPORT FERRY RD. 0.3 miles. WESTPORT FERRY RD becomes WAHKIAKUM FERRY (Check ferry schedule/fares) 1.3 miles. WAHKIAKUM FERRY becomes WA-409 1.7 miles.
- Turn Left onto W. BERNIE SLOUGH RD. 0.8 miles.
- Turn Left onto CROSS DIKE RD. 0.7 miles. Left at 117 Cross Dike Rd.



Times for taking the ferry to/from the field:

Westport → Puget Island = 15 mins AFTER THE HOUR
Puget Island → Westport = ON THE HOUR

THERE WILL BE LIMITED CAMPING ON SITE.

- All persons with onsite overnight parking **MUST** park in designated parking area. Stop at the gate for instructions.

TIPS FOR HANDLERS

1. The field is fenced. However, it is strongly recommended that prior to running your dog, you have good “recall” control over your dog, as the dogs will be off leash.
2. Handlers should wear comfortable, sturdy shoes (no sandals or flip flops, please!) and be physically able to hold and release their dogs, as well as catch them.
3. Handlers may carry toys or treats on their persons to assist with retrieving their dog **at the completion of their run.**
4. Dogs will be brought to the start line on leash and released only upon a verbal signal (“TallyHo!”) from the Huntmaster. Dogs may be released by hand, folded leash or using a traditional lure coursing slip lead,
5. The Huntmaster will instruct the handler to “Retrieve your dog” upon completion of the CAT run. The handler is expected to promptly secure the dog and leave the field with the dog on leash.
6. Handlers are advised to warm up their dogs prior to their run and walk them for about 5 minutes afterwards.
7. Lure coursing is a physically demanding sport so please make sure your dog is in good shape. If you are not sure, make an appointment with a veterinarian to get an opinion.
8. Any person, upon reasonable complaint, may be asked to leave the grounds of the test by the Field Committee and may be disciplined by the AKC.

Children must be under control of their parents or guardian(s) at all times. Neither Willamette Valley Basenji Club (WVBC) nor its members, will be responsible for any accidents at these coursing ability tests.

FOR FIRST TIME COURSERS AND HANDLERS

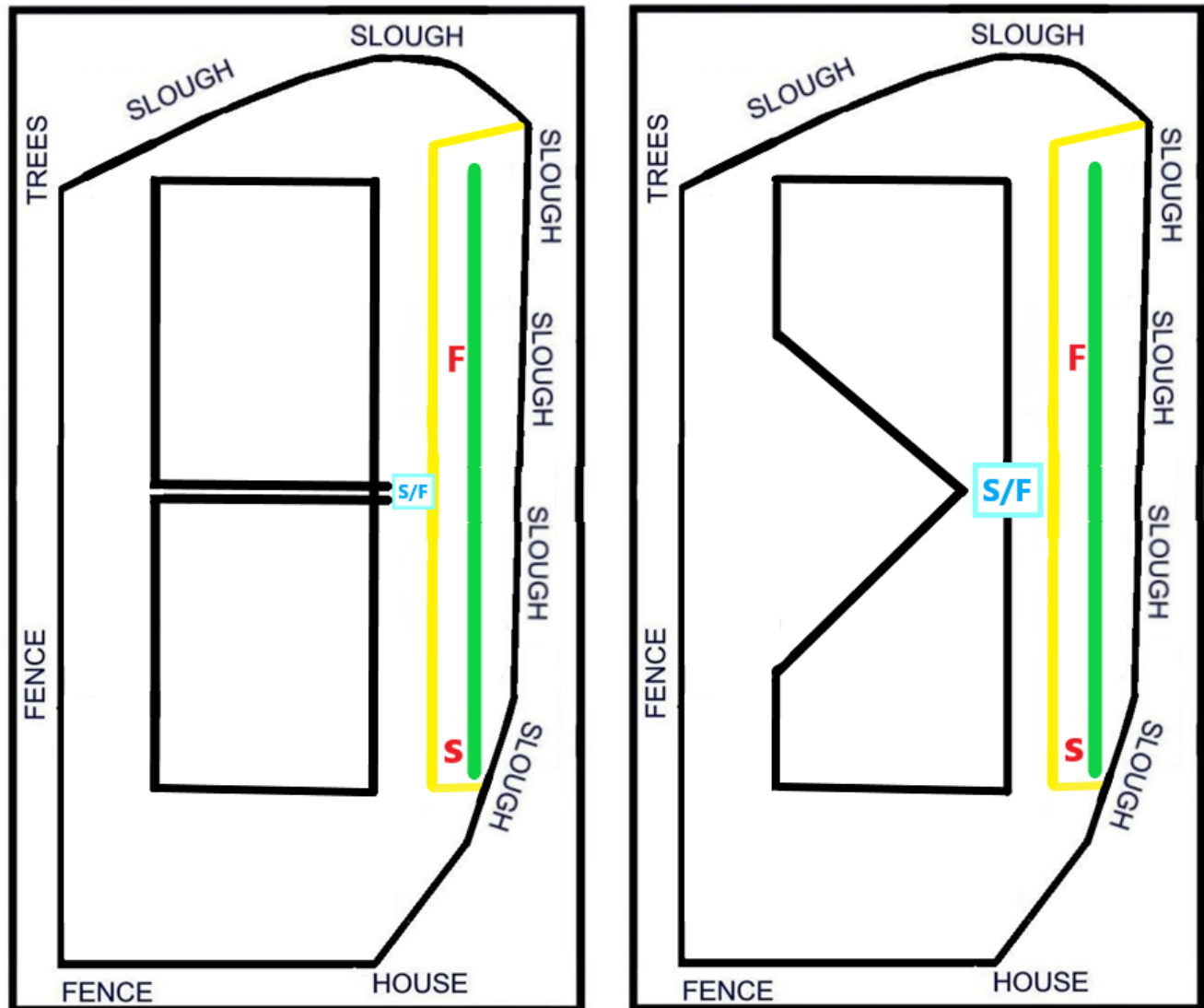
WHAT ARE PRE-ENTRIES? - Entries made before closing date/time.

SLIP LEADS - There is a type of collar for coursing called a slip lead, which is worn only to control the dog prior to “release”. The collar drops away as the dog is released to chase the lure and they run without anything around their necks that could be dangerous. **NO CHOKE COLLARS, HARNESS, OR HALTI/GENTLE LEADER OF ANY KIND MAY BE WORN WHILE RUNNING/TESTING.** Entries may wear a flat collar with no hanging tags (tags may be taped to the collar for safety).

INSPECTION - Dogs will be inspected by a designated Inspection Committee consisting of at least two persons who are members of the Inspection Committee and who shall inspect each entered dog for lameness, fitness to compete and female estrus (in season). Inspection shall take place prior to any form of wrapping being applied to the dog. In the opinion of the Inspection Committee, any entry to be found to be lame, unfit to compete or in season shall not be allowed to enter and the application entry fees shall be refunded.

RUN ORDER LIST – WVBC does not have a run order list. Handlers may line up to run their dog after being inspected. This means they may end up waiting a long or short period of time. Please provide you and your dog with shade and water.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to

periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
